**Membership Report:** Allyn Linas presented the club as having 115 paid members and 60 members from last year who have not renewed as of yet. The club will be kept up to date on all changes to any budget presented. The motion was proposed to accept the budget as presented and the motion was passed.

**Fundraiser Committee:** Cindie Willoughby discussed the upcoming Judged Trail Ride. She said there were plenty of good volunteers and encouraged members to help out by passing out fliers. It will be on June 7th at Tuckahoe Plantation.

We also now have three ways to display your medical information: armbands, neck bands, and clip-on tags. Members must always wear their medical ID as well as have a helmet while mounted. Also, every horse must have a current Coggins if they are to be ridden at a RSRC event. We are trying to tighten up on checking for everyone's safety and because it is the law!

**Christmas Party Update:** Allyn has graciously volunteered to host our party at her new house out off Route 6 past Goochland Courthouse. We have reserved the room at Randolph Macon as well, and we need to make a decision by June. Please be thinking about which location you prefer.
